R1.06 Coaches and Managers - Managers and Coaches must be signed on the Team Registration Certificate for each team they are affiliated with (i.e. Coaches and Managers participating for more than one team must be signed on each team's contract, but may only register on one Team Registration Certificate per Division). Additional Managers and/or Coaches may register through the Divisional Coordinator or representative at a fee set annually by the Board of Directors and must sign a release of liability waiver form as against the Association. Only registered Managers, Coaches, Players and Team Personnel are allowed on the coaching lines and bench areas in all Divisions.

All Others: U15, U17, U19 II, Intermediate II, and Masters Rec: Head Coach: NCCP Competition-Introduction, Softball Certified; Assistant Coaches: Competition-Introduction, Softball Trained.

U19 I, U23 Women's and Women's: Head Coach: NCCP Competition-Introduction, Softball Certified; Assistant Coaches: NCCP Competition-Introduction, Softball Trained

Definitions of terms used for P.W.S.A.: Trained This means a Coach has attended a portion of requirements. For example - a Coach has attended Weekend #1 and Weekend #2 of Competition-Introduction, Softball and completed the Make Ethical Decision On Line Evaluation - their status is "Trained".

Certified This means a Coach has attended and completed all of the requirements, including the On Field Evaluation. For example, a Coach has attended Weekend #1, Weekend #2 of Competition-Introduction, Softball; has completed the Make Ethical Decision On Line Evaluation and had an On Field Evaluation completed (Weekend #3) - their status is "Certified".

It is the Coaches responsibility to provide proof of Certification if required to do so. This applies especially to new Coaches or if there is any upgrade in their Coach education. Copy of Clinic Certificate or NCCP transcript (in the Locker) – U9/U11 and U13; NCCP passport or NCCP transcript (for all others) as required.

- (a) At a Provincial Tournament, participating teams without a properly Certified Coach on the bench, will be fined \$100.00 per game. Exception: Should a properly certified coach be ejected from a game and is the only properly certified coach registered with that team, the \$100.00 fine will not be levied. If ejected from the entire tournament, the \$100.00 fine per game will be levied, until the team has a properly certified coach on the bench.
- (b) Coaches MAY be granted an exemption ONE TIME ONLY, upon written application to their Divisional Coordinator.

NOTE: Teams participating in Canadian Championships, Canada Summer Games and/or Ontario Summer Games are required to have NCCP Certified Coaches as prescribed by Softball Canada and/or the Government of Ontario. All coaches/managers, in order to coach in the Provincial Women's Softball Association, must have taken the Respect in Sport course for Activity Leader-Coach.

Coaches'/Managers' certification numbers from the program must be provided to the Divisional Coordinator before official team registration certificate will be approved.

(d) Coaches MAY be granted an exemption ONE TIME ONLY, upon written application to their Divisional Coordinator.

Managers and Coaches must be signed on the Team Registration Certificate for each team they are affiliated with (i.e. Coaches and Managers participating for more than one team must be signed on each team's contract, but may only register on one Team Registration Certificate per Division). Additional Managers and/or Coaches may register through the Divisional Coordinator or representative at a fee set annually by the Board of Directors and must sign a release of liability waiver form as against the Association. Only registered Managers, Coaches, - 33 - Players and Team Personnel are allowed on the coaching lines and bench areas in all Divisions. All participating teams must have the following minimum NCCP Softball Certification as follows:

Additional Managers and/or Coaches may register through the Divisional Coordinator or representative at a fee set annually by the Board of Directors and must sign a release of liability waiver form as against the Association. Only registered Managers, Coaches, - 33 - Players and Team Personnel are allowed on the coaching lines and bench areas in all Divisions. All participating teams must have the following minimum NCCP Softball Certification as follows:

This condition will eliminate conflicts of interest, real or perceived, between paid skills instructors and the teams their students are playing with and their Associations. This will reduce the number of complaints received by the PWSA regarding these conflicts of interest, tampering and interference.

#### BE IT RESOLVED THAT (Motion: State whether revision, addition, deletion, etc.)

Addition> Tier 1 tryouts from U15 thru U19 can commence on Labour Day and continue for 3 additional days. On the Thursday following Labour Day Tier 1 teams must be required to have, at minimum, made their first round of cuts and have their 'tryout roster' down to 15 players maximum and on that said Thursday Tier 2 tryouts may now begin, but not before.

#### **RATIONALE**

A lot of drama and stress these past few weeks with new teams popping up, players changing centres and tryouts/teams being held in limbo waiting for Tier 1 teams to make cuts and seeing where players may land, and in some instances teams ended up folding due to not being able to attract enough players to form a team. Maybe follow the hockey model where Triple A has a week, then it falls to Double A, etc, to select their teams but of course we wouldn't need as many days to form teams as we aren't dealing with the number of players that hockey does.

Or could look at the option of allowing teams to sign players beginning Sept 1<sup>st</sup>, and if some teams can complete their roster before Labour Day would also eliminate some of the uncertainty and stress involved in the process.

#### **FINANCIAL IMPLICATIONS**

Would have some teams saying they cannot declare their Tier that early in the fall, but the majority of teams are already posting their intentions by that time. Would also delay Tier 2 and then a big push for all teams to hold tryouts but need to do something to improve on how things went this tryout season as it was very stressful for almost all involved.

#### WHEREAS (Article as currently written)

R1.12 Evaluation and Recruiting -

- (a) Club team tryouts or player evaluations in the U9 through U19 divisions cannot commence before Labour Day. Failure to abide by these rules will result in the offending coach being denied Association membership for one (1) year.
- (b) All Association coaches, managers, parents, and players are not able to recruit P.W.S.A. players from other teams at any time during the playing season ending August 31st. If a coach is found to be recruiting players during the season, they will be denied membership for one (1) year.

In addition to any suspensions imposed on any coach by P.W.S.A. for illegally recruiting a player, the player or players involved shall not be allowed to play for that team while the coach is under suspension. The player or players are free to play for any other team.

Note: Any member of the association that submits a complaint pertaining to evaluation & recruiting must document their complaint on the approved form, and send the form along with a processing fee of \$250.00 payable to P.W.S.A. If after - 36 - investigation the association deems the complaint to be valid, the processing fee is returned. If, however, the complaint is unfounded, the submitter will lose out on the fee.

#### BE IT RESOLVED THAT (Motion: State whether revision, addition, deletion, etc.)

(b) All Association coaches, managers, parents, and players are not able to recruit P.W.S.A. players from other teams at any time during the playing season ending. "Season end" defined as the Monday following the last day of the Nationals, Easterns, Westerns or Provincials for each division as posted on the PWSA competitions page. If a coach/parent/player is found to be recruiting players during the season, they will be denied membership for one (1) year. Note the division will be the division the athlete is registered in.

In addition to any suspensions imposed on any coach/parent/player by P.W.S.A. for illegally recruiting a player, the player or players involved shall not be allowed to play for that team while the coach(s)/Association is under suspension. The player or players are free to play for any other team/association.

#### **RATIONALE**

To allow teams/athletes to plan for the next season once their own season is over.

R4.06 Tie Breaker - In all Divisions, after seven (7) innings of regulation play, the Tie Breaker shall be used. In the U13 Divisions, tournaments with time limits on games, the Tie Breaker shall be at the end of seven (7) innings or when the time limit is up. Exception: In the U9/U11 Divisions with time limits on games, the Tie Breaker shall be at the end of six (6) innings or when the time limit is up. Exception: In tournaments using pool play/round robin format, ties after 7 innings shall stand.

At the completion of the round robin/pool play portion of such tournaments, the Association Tie Breaker shall be:

- (1) Winner of games between the tied teams.
- (2) Difference plus or minus of total runs scored with the limit of seven (7) plus or minus per game.

Full innings only may be used.

- (3) Least runs allowed.
- (4) Most runs scored.

WHEREAS (Article as currently written)
R8.02 Acts of Suspension - Teams, coaches, managers or players will be suspended for conducting themselves in an unsportsmanlike and undesirous manner and without limiting the generality of the foregoing, for the following specific acts:
(a) Permitting betting or improper conduct by players, coaches or managers at games. Automatic suspension for a period of one year from the date of suspension.
(b) Offering, agreeing, conspiring or attempting to lose any games, or being interested in any pool or wagers thereon. Automatic suspension for a period of one year from the date of suspension.
(c) Deliberately degrading the image of the Association or their representatives. Goes to a Discipline Committee. Suspension depend on severity.
(d) If a Manager, Coach, or member of the team is involved in a major incident at a Canadian Championship. Automatic suspension from participating in a Canadian Championship for a period of 2 years. Major defined by report from Softball Canada - examples Physical altercations, Police involvement.

(e) Knowingly playing with or against a player, coach or manager who has been expelled or suspended. Automatic suspension for a

(f) Refusing to sign the release of liability waiver form. Suspension until such time as the release of liability form has been signed.

(g) Using a player who is not eligible to play on that team. Automatic suspension for a period of two months.

period of two months.

- (h) Fighting with other coaches, managers, players, officials or spectators. Goes to a Discipline Committee. Suspension depends on severity.
- (i) Verbal abuse, harassment of any official, player or spectator. Goes to a Discipline Committee. Suspension depends on severity.
- (j) If a Manager, Coach, or member of the team management, offers money to a player for their services. Automatic suspension for a period of one year from the date of suspension.
- (k) If a player having demanded money for their services. Automatic suspension for a period of one year from the date of suspension.
- (I) Submitting an N.S.F. cheque for payment of any fees to the Association. Automatic suspension until cheque and all charges are cleared.
- (m) When a player leaves their team, they must meet all financial obligations and return all parts of their uniform and property of the team/local organization, or pay the cost of the same, before playing with another team. Failure to do so will automatically place said player under suspension until all property is returned or paid for.
- (n) The consumption of alcoholic beverages or any other impairment inducing substances on or near diamond facilities. Exception: Any Licensed area. Automatic suspension for game, if a single game and/or automatic suspension for Tournament, if a Tournament.
- (o) Any cases of sexual abuse/harassment should be immediately reported to P.W.S.A. Any physical assault, discriminatory public tirades, or any situation in which the police are involved should be immediately reported to P.W.S.A. (copy both the President and Secretary). Failure to do so will result in an Automatic suspension of one year from the date of suspension.

Note: Teams/Associations must submit any matter involving unpaid dues to that Team/Association no later than 7 days prior to the Provincial Championship in the division they are affiliated with. All other issues that may result in suspensions or discipline must be submitted by September 5th of the current year.

Note: Any discipline matter/suspension will be reported to a minimum of two (2) directors of the local/member Association Board
